Information Notice on the Processing of Personal Data pursuant to Articles 13 and 14 of Regulation (EU) 2016/679.

A. Data Controller and Contact Information

The Data Controller is the Italian Association of Physics Students (hereinafter referred to as AISF), represented by its pro tempore legal representative, the President, with its registered office at Via Pietro Giuria 1, 10125 Turin (email address: presidente@ai-sf.it).

B. Purposes of Data Processing and Legal Basis

AISF is a non-profit social promotion association with the purpose of creating a national network of physics students and promoting scientific research, governed by its Statute, Internal Regulations, and Privacy Policy.

The personal data provided will be used by AISF in the context of the event “Trento - Innsbruck Quantum Information Tour,” hereinafter referred to as “TIQIT,” which will take place in the cities of Trento and Innsbruck from February 22, 2026, to February 28, 2026.

The personal data provided, including portraits contained in photographs/videos/audio recordings, will be processed in compliance with the current data protection regulations and confidentiality obligations. AISF processes personal data based on the consent provided by the data subject pursuant to Article 6(1)(a) of EU Regulation 2016/679.

Audio/video recordings are treated as temporary processing activities intended for the occasional publication of articles and therefore comply with the provisions outlined in the Ethical Rules for the Processing of Personal Data in the Exercise of Journalistic Activities, published pursuant to Article 20, paragraph 4, of Legislative Decree No. 101 of August 10, 2018, dated November 29, 2018.

C. Types of Data Processed

The personal data collected and processed by the Data Controller for the purposes outlined above include the following:

- Identification data;
- Contact information.

Additionally, photographs, video recordings, and audio recordings in which identifiable data subjects appear will be processed in compliance with current regulations and confidentiality obligations.

D. Methods of Processing

The processing of personal data will be carried out using manual, electronic, and telematic tools suitable for ensuring the security and confidentiality of the data. For the purposes outlined above, the data will be processed by authorized personnel (e.g., individuals in charge of technical support for the platform). Within the scope of the processing purposes specified, personal data (including images and audiovisual recordings) may be communicated, published, and/or disseminated in any form. Such data may be published on the AISF website (<https://ai-sf.it>) and on AISF's official pages, as well as those of its Local Committees, on Facebook, Twitter, YouTube, Instagram, Spotify, and LinkedIn.

Consequently, these data may also appear in search results on common search engines when queried by third parties.

The data will not be used for commercial or marketing purposes, nor will they be shared with third parties.

E. Data Transfer to Third Countries

Personal data may be transferred to third countries outside the European Union, as the Data Controller uses Google services. Google relies on IT infrastructure, necessary equipment for network and user interconnection, and logging centers located in non-EU countries. Google has adhered to the Data Privacy Framework for the transfer of EU-US data based on the adequacy decision adopted on July 10, 2023, by the EU Commission pursuant to Article 45, paragraph 3 of the GDPR.

F. Release for the Use, Recording, and Publication of Content (Audio, Video, Images, Photographs, and Statements)

In accordance with Articles 96 and 97 of the Law of April 22, 1941, No. 633, regarding the protection of copyright and other related rights, as well as within the limits of Article 10 of the Civil Code, I, the undersigned:

- Agree to be filmed, photographed, and/or subject to any other type of multimedia recording during "TIQIT."
- Grant the Italian Association of Physics Students (AISF) the right to use my image, video, or any other form of multimedia recording that makes me recognizable on their

platforms, including the website and social media (such as Facebook, Twitter, YouTube, Instagram, Spotify, and LinkedIn), brochures, posters, informational and promotional materials.

- Acknowledge and understand that for certain transmissions, downloading is permitted.
- Authorize AISF to display and project the images during exhibitions, debates, conferences, and to use them for future events/works.
